

TERMS AND CONDITIONS OF EVENT REGISTRATION, ENTRY AND ATTENDANCE

Event registration, entry and attendance are subject to the below terms and conditions and with our [Privacy Statement](#) (collectively, 'Terms'). By registering and attending the Event you acknowledge you have read and agree to these Terms (as updated periodically). If you register online before the Event you agree to check these Terms immediately before attending to make sure you have a current understanding of them. If you do not agree to these Terms you must not attend the Event.

1. Definitions

In these Terms: 'we', 'us' and 'our' mean Exhibitions and Trade Fairs Pty Ltd of 5/21 South Street, Rydalmere, Sydney, 2116, NSW, Australia ABN 72 101 130 527; 'you' and 'your' refer to persons who register and/or attend the Event; 'Event' means the Australian Energy Storage Conference and Exhibition held on 2 and 3 June 2021 at the Venue and any associated Industry related Tours agreed between you and us; 'Industry' means the energy and energy storage industry; 'Loss' includes any liability, cost, claim, damage, loss or expense to persons or property; 'Management' means the Venue owner and/or manager; 'Tours' means visits to locations other than the Adelaide Convention Centre organised by us in connection with the Event; 'Venue' means the Adelaide Convention Centre Adelaide South Australia 5001.

2. Eligibility to Attend the Event

- 2.1 This Event is open to professional and business people who (a) are 18 years and older (b) are engaged in the Industry (c) complete the registration process; (d) provide requested identification, contact or other information.
- 2.2 A valid visa to enter Australia may be required if you are based overseas and you should contact the Australian Embassy in your country for further information. We do not issue invitations for overseas persons wishing to attend but the "confirmation" you receive after successfully registering may assist with your visa application.

3. Event and Registration

- 3.1 While you are required to register to attend the Event, registration will not guarantee your entry to the Event or to specific displays or activities.
- 3.2 We do not represent that there will be space for you to observe or attend any particular display or activity.
- 3.3 We may postpone or change the Event dates or duration or the hours during which the Event is open or change the Venue. We may also cancel, withdraw, postpone or re-schedule or otherwise vary any displays or activities.

4. Safety and Security

- 4.1 You must comply with applicable health and safety laws, report all accidents or emergencies or other incidents to us or to Management and follow all safety and security related directions and the Venue's rules.
- 4.2 CCTV or other surveillance may be used for security or safety reasons but does not guarantee your safety or security.
- 4.3 Smoking is not permitted at the Venue (except at officially designated smoking areas - if any).

5. Photographs and Recordings

- 5.1 You consent to being photographed, filmed or recorded and for such photographs, images or recordings to be used by us, Management or other third parties for any legitimate purpose without acknowledgement or compensation to you.
- 5.2 You are not permitted to bring photographic or recording equipment to the Event or take photographs, videos or other recordings at or of the Event without our prior written approval.

6. Risk and Indemnity

- 6.1 You enter the Venue, attend the Event and participate in a Tour voluntarily and at your own risk, including risk to persons and property.
- 6.2 To the extent permitted by applicable laws, you agree (a) that neither we, nor Management, will be liable to you for and (b) to waive and release us and Management from, all Loss you suffer in connection with your entry to, or attendance at or participation in (or non attendance) at, or otherwise in connection with, the Event (expressly including Tours and any event or incident outside our control).
- 6.3 You agree to indemnify us and Management from any Loss caused by, arising out of, or connected, with your entry or attendance at the Event, participation in a Tour or your breach of these Terms.
- 6.4 Nothing in these Terms is intended to exclude, restrict or modify rights which you may have under consumer protection laws which cannot be excluded, restricted or modified by agreement.

7. Privacy

- 7.1 You consent, under privacy and other applicable laws, to the collection of your personal information for the purpose of conducting the Event (including your participation in instant messaging and a meeting maker facility via the Event website, if available) and the disclosure of your personal information to us for the purposes stated in ETF's Privacy Policy including to contractors and others involved in organising and participating in the Event and to our suppliers for the Event.

8. General Rules

- 8.1 We and Management may at our discretion (a) refuse entry or remove any person from the Event, Tour or Venue (b) inspect and/or search bags and/or search persons (including their clothing and/or personal items) when entering or exiting or otherwise attending the Event, a Tour or Venue.
- 8.2 Vehicles and other transportation devices (such as skateboards, bicycles, scooters and roller blades) and animals are prohibited except those authorised for guide or disability purposes or pre-approved by us. Any items which may cause a nuisance or danger are also prohibited and any such items brought to the Venue or on a Tour are subject to confiscation.
- 8.3 You must comply with all rules, signs and notices at the Venue and follow any reasonable directions given by us or Management.
- 8.4 You must not undertake any unauthorised commercial activity at the Event, Tour or Venue, including that you must not distribute or display any unauthorised promotional or advertising materials.
- 8.5 You must comply with the dress code for the Event and Tour which is business or smart casual attire.
- 8.6 These Terms are governed by the laws and courts of New South Wales, Australia.
